This classification report defines the classification assigned to the above-mentioned product (s) in accordance with the procedures given in the NF EN 13501-1 standard: September 2018.

## 2. Details of classified product

### 2.1. Product standard

NF EN 14041 (2005): "Resilient, textile and laminate floor coverings - Essential characteristics".

# 2.2. Product description

Axminster woven cut pile carpet with patterns (EN 1307 family).

Use surface: 80% wool – 20% polyamide

Type of backing: polypropylene Nominal mass per unit area: 2150 g/m² Nominal total thickness: 9,7 mm Nominal total pile thickness: 6,35 mm

Flame retardant: No

## ELEGANCE BLACK FR 4 mm underlay:.

Nominal mass per unit area: 960 g/m<sup>2</sup> Nominal total thickness: 4,0 mm

Installation: Axminster woven carpet tested glued on ELEGANCE BLACK FR 4 mm underlay. Together tested glued over a fibre-cement board classified A2<sub>fl</sub>-s1 or A1<sub>fl</sub> with a density  $(1800 \pm 200) \text{ kg/m}^3$  and thickness  $(20 \pm 2) \text{ mm}$ .

Type of glue: Acrylic glued with deposing 350 g/m<sup>2</sup>

### 5. Limitations

This classification document does not represent type approval or certification of the product.

"The classification assigned to the product in this report is appropriate to a declaration of conformity by the manufacturer within the context of system 3 of AVCP and CE marking under the Regulation 305/2011/EU of the European Parliament and of the Council of 9 March 2011 laying down harmonised conditions for the marketing of constructions products.

The manufacturer has made a declaration, which is held on file. This confirms that the products design requires no specific processes, procedures or stages (no addition of flame-retardants, limitation of organic content, or addition of fillers) that are aimed at enhancing the fire performance in order to obtain the classification achieved. As a consequence the manufacturer has concluded that system 3 attestation is appropriate.

The test laboratory has, therefore, played no part in sampling the product for the test, although it holds appropriate references, supplied by the manufacturer, to provide for traceability of the samples tested."
